Pornographic or indecent materials and /or actions will not be permitted at or during the show dates. MAAS reserves the right to alter the floor plan in accordance with the fire marshal, show room changes and changes in exhibitor's booth locations when needed and has the right to refuse the sale of booths. Exhibitors will hold harmless, protect and free of any responsibility MAAS against any damages, all legal disputes and advertising claims, offers, accidents, incidents, any exhibitors' expenses or loses, as well as errors in printing in the hard copy show directory, electronically and on MAAS website or on all advertising as well as warehouse storage, drayage and shipping damages occurring before, during the show dates, overall pre-show set up, break down and after. MAAS does not offer credit for exhibitor no-shows or cancellations. No booth will be held if payment has not been received within 10 days after show management receives this agreement. A minimum of 50% deposit must be paid within 10 days of the date of this agreement. All balance due must be paid 150 days before the show date. We require that all foreign language exhibitors translate this agreement for full understanding. MAAS is not responsible for any business transactions, sales or lack of sales that are done before, during the trade show and after between exhibitor and buyer. Any break down before the assigned show closing hour will be charged a penalty. Exhibitor accepts co-location of another trade show. It is prohibited for any person that is not an official exhibitor to sell their products at MAAS. Any damages to any part of the booth package, rug, to the convention center, show rooms or rentals by exhibitor will be charged for the damage costs and/or repairs. Exhibitor will hold harmless and protect MAAS, its members, owners, co-organizers, directors, employees, its company corporation, as well as affiliates of all show management positions from and against any and all legal actions, disputes and potential lawsuits.
